Insured	Federal Home Loan Mortgage Corporation ("Freddie Mac")
Covered Loans	Initial reference pool of \$56.2B associated with STACR 2017-DNA3. Pool includes conventional fully amortizing 30-year fixed rate first lien mortgages with original LTVs greater than 60% and less than or equal to 80%, funded by Freddie Mac between November 1, 2016 and March 31, 2017.
Insurance Coverage	Credit Insurance Policy with a maximum loss limit of \$400.2M on losses related to Credit Events (as defined in the insurance policy) on STACR 2017-DNA3. Reference Tranches M-1H, M-2H and B-1H. Freddie Mac fully absorbs any losses related to Reference Tranches A-H.
Counterparties	2 International & Domestic insurance providers 17 International & Domestic reinsurers
Effective Date	October 2017
Maturity Date	March 2030
Freddie Mac Min	Freddie Mac required the participating counterparties to establish
Collateral Amount	collateral trust accounts that hold cash and cash equivalent securities. The aggregate minimum collateral amount required by Freddie Mac was approximately \$64.1M ¹
